Emergency Pool Operation and Use Rules in Response to Covid-19

Adopted June 25, 2020
\*IF RULES ARE NOT FOLLOWED – POOLS WILL BE CLOSED\*

Rancho Highlands Community Association makes no representation as to the sanitization or disinfected condition of the pool or any part of the pool area. Rancho Highlands Community Association has made every effort to ensure that the pool and pool area is sanitized, but can make no guarantees that the pool and pool area are clear of Covid-19. Use of the pool or pool area is strictly at your own risk.

These Pool Operation and Use Rules are specifically in Response to Covid-19 and are in addition to the Pool Rules currently in effect and listed below.

- Pool hours will temporarily be changed to Thursday 10:30am to 3:30pm
   Friday 10:00am to 3:30pm
   Saturday 12:00pm to 5:30pm
   Sunday 12:00pm to 5:30pm
   Pool use hours may be modified without notice.
- NO guests allowed.
- Pool occupancy limit will be decreased to 50% 40 people maximum
- Spa will be closed.
- Time will be limited if maximum capacity is met.
- Residents must wash hands frequently with soap and water, cover coughs and sneezes. Residents
  who are experiencing symptoms of illness including a fever of 100 F or above, sore throat, runny
  nose, chills, not feeling well, sneezing, coughing, abdominal pain, or diarrhea must avoid the pool
  area.
- No large groups or parties allowed. Homeowners from the same household may swim together.
   Groups will be limited to six (6) or less. Residents must maintain a six (6) feet separation between swimmers.
- Residents should wear protective face coverings when not in the pool and traveling through common areas of the property, include to and from the pool and shared restrooms.
- Residents are required to bring and use hand sanitizer.
- Pool restrooms will be checked daily to ensure they are fully stocked with hand soap and paper towels. Please contact the pool monitor immediately if restrooms are not properly stocked.
- Commonly touched surfaces including but not limited to gate, latch tables, chairs, drinking fountain, pool handrails, countertops, restroom door handles, restroom light switches, restroom latches, restroom faucets, and shower handles will be sanitized by the Rancho Highlands janitorial contractor daily.
- No running, diving, glass containers or pets within the pool area.

- No alcoholic beverages and no smoking permitted in the pool area.
- Use of pool facilities is a privilege. Problematic conduct may result in immediate removal from the pool facility.
- Children under the age of fourteen (14) must be accompanied by a responsible adult resident when using the pool. (California Department of Health Services, Title 22).
- Running, rough housing, excessive noise, etc. is not permitted. No loud music.
- Proper swim attire is required in the pool.
- Barbecues are not permitted in the pool area.
- Management or the Community Association is not responsible for accidents, injuries or theft.
- The association does not supply any type of Lifequard or water safety supervisory service.
